### **Charitable Aims**

Our charitable aims are: To promote humane behaviour towards animals by providing and supporting initiatives to improve dog welfare related to:

- a) genetic and breed related health, breeding, rearing and selling practices; and*
- b) to inform the general public about irresponsible dog breeding in order to make them aware of the potential impact on their dogs' health and welfare.*

DBRG's Strategic Plan for 2018-2021 is: 1) Developing DBRG as a sustainable organisation, 2) Education and raising awareness, 3) Legislative change to meet the needs of dogs in the 21<sup>st</sup> century, 4) Bringing experts together and disseminating expertise, 5) Changing behaviours of owners and breeders.



### **Chairman's Introduction**

2018 has been a busy and momentous year: our first year as a Registered Charitable Trust. Highlights have been the completion of our three year Strategic Plan; uploading important advice to puppy buyers on our website; producing a new information leaflet; helping to achieve major changes in the

regulation of dog breeding (*Regulations for Animal Activities Licensing*, October 2018); helping to achieve the Government's promise to ban the third party sale of puppies; winner of the CEVA Animal Welfare Award for Best Charity Team of the Year; invitation to become a collaborative partner in International Partnership for Dogs (IPFD); becoming an Associate Member of the Canine and Feline Sector Group (CFSG); presenting our position paper, *The Animal Welfare Act and the Protection of Offspring* to the Canine And Feline Sector Group Annual General Meeting; achieving DBRG representation on the CFSG working group on Conformation Welfare Problems; launching our Student Ambassador Scheme.

## **External meetings and events**

January

CF attendance at Dogs Trust Research Meeting: Project Investigating size, source and movement of domestic dogs in the UK.

CF meeting with Helen Black (Community Voluntary Service, South Gloucestershire) to work on the three year plan, wording of leaflet to comply with Charity Commission (CC) requirements, writing a brief history of DBRG for the CC.

February

March

**APGAW Big Tent Meeting.** Attended by Defra Minister, Lord Gardiner, Chairman of the Animal Health and Welfare Board for England, Michael Seal, Mark Berry, Local Authority Animal Welfare Group. The meeting outlined the new risk-based system under the new Animal Welfare Licensing Regulations. In the working groups, DBRG requested that the issue of the Protection of Offspring be taken forward by the All Party Group for Animal Welfare (APGAW), the Canine and Feline Sector Group (CFSG), and the Animal Health and Welfare Board for England (AHWBE). Several members of DBRG attended.

**APGAW** Panel discussion and networking event: **Implementing Sentience Policy** Key speakers, Paula Sparks, ALAW, Mike Radford, Animal Welfare Law, University of Aberdeen, Dr Penny Hawkins RSPCA, Dr Steven McCulloch, Centre for Animal Welfare, University of Winchester. CF represented DBRG.

April

DBRG is awarded winner of the Best Charity Team of the Year at the CEVA Animal Welfare Awards in Birmingham.

May

DBRG attended the **Canine and Feline Sector Group (CFSG) Big Tent** meeting. At this meeting the 2018 Regulations on Animal Licensing Guidance were outlined. A proposal was put forward by DBRG that the programme of work for the CFSG for 2019 should include additional regulatory protection of offspring under the Animal Welfare Act.

June

DBRG will be represented on the **CFSG Conformation Working Group** by Dr Dan O'Neill.

At the DBRG meeting Ian Seath, Chairman of the Dachshund Breed Health Council, presented the Breed Health Plan for the Dachshund breed. It is hoped that other breeds would bring out similar plans to improve the health of their

own breeds. Recognition was acknowledged of the crucial role that Breed Clubs and Breed Health Co-ordinators had in setting the standard for ethical breeding.

### **Animal Welfare Foundation (AWF) RSPCA Puppy Contract**

The AWF and RSPCA launch the new Puppy Contract to assist breeders and puppy buyers. Use of the Contract will ensure that a breeder has done everything s/he can to breed healthy puppies. In turn the puppy buyer undertakes to provide a good home and care for their new puppy. DBRG has supported the Puppy Contract from its inception and it can be downloaded from our website.



July

**Meeting with Defra Officials** Carol Fowler and David Grimsell met with Defra officials to present the DBRG's position paper on the Animal Welfare Act and the Protection of Offspring. It was acknowledged that the New Licensing Regulations, Schedule 6.6 *Protection from pain, suffering, injury and disease* includes the statement, *No dog may be kept for breeding if it can reasonably be expected, on the basis of its genotype, phenotype or state of health that breeding from it could have a detrimental effect on its health and welfare or that of its offspring.*

The Defra officials (Philip Alder, Rebeca Garcia, Andy Howarth) listened to our concerns that such a duty of care should apply to those breeding dogs outside

the licensing regime also. The officials indicated that they were favourably disposed to the development of a Code of Practice for the Breeding of Dogs.

August

CF and Julia Carr were invited to a **Garden Party at Number 10 Downing Street** to hear Defra Minister, Michael Gove, announce the Government's intention to ban the third party sale of puppies and enact 'Lucy's Law'



September

At the DBRG meeting, Dr Tom Lewis gave a presentation on **Canine Genetics** and the possibilities for breeders provided by the use of DNA testing, use of the Canine Health Schemes and Estimated Breeding Values (EBVs). EBVs are now available for Hip and Elbow Dysplasia in some breeds which if used widely by breeders will lower the incidence of these two painful and debilitating genetic diseases.

Carol Fowler attended the **Kennel Club's Breed Health Co-ordinators Symposium** at Stoneleigh in Warwickshire. Also present were DBRG members, Dr Dan O'Neil (Vet Compass, Royal Veterinary College), Dr Rowena Packer

(Royal Veterinary College), Andrew Gillon (BVA Canine Health Schemes) and Lesley Field (Springer Spaniel Breed Health Co-ordinator).

At the Symposium Dr Mike Starkey gave a presentation on Canine Cancers.

Dr Rosario Cerundolo gave a presentation on Common Skin Problems in the Dog.

### **International Partnership for Dogs (IPFD)**



DBRG was invited to be a collaborative partner in the International Partnership for Dogs (IPFD). This organisation holds Dog Health Workshops at different countries in Europe every two years where national Kennel Clubs meet with scientists in an effort to share good practice and work together to address canine health and welfare concerns worldwide. To date DBRG is the only organisation representing dog owners. We have an important role to play in ensuring that the needs of dog owners for a healthy and happy pet dog are given priority.

IPFD now has a **Harmonisation of Genetic Tests** website, listing all of the available DNA tests on a breed by breed basis. Our own DogBreedHealth website has been updated to reflect this development.



Members of DBRG will be attending the 2019 IPFD Dog Health Workshop held at Windsor, UK in May, hosted by the UK Kennel Club.

DG and CF attended the **Canine and Feline Sector Group (CFSG) Annual General Meeting** to present our position paper, The Animal Welfare Act and the Protection of Offspring. Our paper was well received and CFSG have agreed

to move forward in creating a **Code of Practice for Dog Breeding** which DBRG will be closely involved in. Lobbying for additional statutory regulations to protect offspring from health and welfare harms will be considered at a later date.

October

A revised **DBRG information leaflet** has been produced to reflect the October 2018 Regulations for Animal Activities Licensing.
